#### **RABIES VACCINATION Sec. 22-339b**

In summary, Rabies vaccination required for dogs and cats. Any owner or keeper of a dog or cat of the age of three months or older shall have such dog or cat vaccinated against rabies. Any animal vaccinated prior to one year of age or receiving a primary rabies vaccine at any age shall be considered protected for only one year and shall be given a booster vaccination one year after the initial vaccination and shall be vaccinated at least every three years thereafter. Those animals revaccinated after one year of age shall be given booster vaccinations at least every three years thereafter. Proof of vaccination shall be a certificate issued by a licensed veterinarian in accordance with subsection (a) of section 22-339c. A licensed veterinarian, upon request of any Animal Control Officer shall submit to such officer a copy of such certificate and any associated rabies vaccination records for such dog or cat that has bitten a person or another animal. (b) The State Veterinarian or the Commissioner of Agriculture, or the commissioner's designee, may grant an exemption from vaccination against rabies for a dog or cat if a

licensed veterinarian has examined such animal and determined that a rabies vaccination would endanger the animal's life due to disease or other medical considerations. Such exemption may be granted only after the veterinarian has consulted with the State Veterinarian, the Commissioner of Agriculture, or the commissioner's designee, and completed and submitted to the department an application for exemption from rabies vaccination on a form approved by the Department of Agriculture. Certification that a dog or cat is exempt from rabies vaccination shall be valid for one year, after which time the animal shall be vaccinated against rabies or the application for exemption shall be renewed. (c) Any veterinarian aggrieved by a denial of a request for an exemption from rabies vaccination by the State Veterinarian, the Commissioner of Agriculture or the commissioner's designee may appeal such denial as provided in the Uniform Administrative Procedure Act, sections 4-166 to 4-189, inclusive. (d) Any violation of this section shall be an infraction.

#### **DESMOND'S LAW**

March 28, 2016 with 34 in favor and 9 opposed, Desmond's Law passed the Judiciary Committee! This law is one step closer to making this important legislation a reality. The next steps is the bill will probably need the approval of another Committee, and then it will go to the House and Senate. The aim of this bill is to reduce the number of dismissed cases and help ensure that punishment fits the severity of the violence committed and provide the victim a voice in the courtroom. With the passage of this bill, an individual might think twice before they cause injury to an animal. We've all seen them. Perhaps we've crossed the street, turned around and walked back the way we came, or shortened our own dogs leash to avoid the dog with that thing on their nose, lest they go on the attack. That "muzzle" as I've heard it called many times is indeed, not a muzzle. There are many companies that manufacture these, and they go by different names. Halti and Gentle Leader are two of the most common. Everyone is familiar with the dog harness, which typically goes across the dog's chest, under its belly and clips on their back. While these are highly regarded by most of the population as an alternative to a flat collar and leash to control the more feisty dogs, they are not for everyone. When I first adopted two of my girls within months of each other, we attended every training class available, not just for training but for the socialization aspect as well. They passed all of the classes with flying colors, even their Canine Good Citizenship tests. They could heel with the best of them provided they were in the mood. Despite all of the training there were always certain situations where my sweet 50 lb. ladies would get so excited they would pull like horses doing a tractor pull. We worked and worked on walking with me. Finally, I spoke with my trainer regarding options that would leave my arm in its socket during those high excitement times. She recommended the typical harness at first, and with great anticipation we gave it a whirl. Turned out not for us. The fact that the harness went across their chest gave them a stronger, wider base with which to pull. Onto

our next experiment, the Easy Walker. Again, these go by many different names depending on the company. These harnesses are different than the typical harness in that the leash clips to the front of the dogs chest so you have more control when they pull. Fabulous! Except my girls quickly learned that if they walked sideways (really!) they could still outsmart me and the Easy Walker. Finally, we tried the Gentle Leader. Now this was a whole new ballgame! The Gentle Leader has a loop that goes over the dog's muzzle, clips behind their ears, and the leash clips under the dogs chin. All without impeding the dog's ability to open their mouth to pant, drink water, eat, etc. An additional benefit of the Gentle Leader is that the strap that goes over their muzzle hits a pressure point on their noses that causes them to relax. The biggest difference is that they cannot pull, no matter how hard they try because the leash is attached to their nose. I noticed a change in them the minute I put it on. Whenever I brought them to a new place or had them in a new situation I used it. Basic walks did not require it. But I noticed the looks from other people, and heard the comments that my dogs were dangerous, they shouldn't be out in public if they require a muzzle and other similar comments. Please, keep in mind that each and every dog is different, just as each person is different. There are some great options out there. Take time to research what is best for you and your companion. Ask questions of the owner if you are uncertain about a particular dog.



#### 'NOT TESTED ON ANIMALS' VS. 'CRUELTY FREE'

Designation as "cruelty-free" or "not tested on animals," or even the image of a bunny on a label may only refer to the finished product, when in fact, most animal testing occurs at the ingredient level. Furthermore, while company may claim, "We do not test on animals," it could still contract other companies to do the testing. The only way to be 100% certain a company is cruelty-free is to buy products from companies that have been certified by the Leaping Bunny Program, which requires that no animal testing be used

in any phase of product development by the company, its laboratories, or ingredient suppliers. Neither the U.S. Food and Drug Administration (FDA) nor the U.S. Consumer Product Safety Commission require animal testing for cosmetics or household products. More and more companies are joining the Leaping Bunny Program each month. It boasts over 600 companies including well-known brands such as Burt's Bees, Method, Mineral Fusion and Seventh Generation.

#### **ANTI-DOG FIGHTING CAMPAIGN**

The Anti-Dog Fighting Campaign is a worldwide Organization that investigates, promotes awareness and battles for an end to dog fighting. It is made up of advocates and investigators who devote time to combating the issues of dog fighting. The ADFC battles for harsh punishment for the offenders who commit these crimes, for stronger laws to be made in countries who have no laws to stop this horrendous blood bath some call "sport". They go to schools, expos, public meetings, rallies, etc. to speak out. They battle in legislative changes in laws regarding dog fighting and need for animal abuse offender registries. They work hard to convince state officials to see the horrors and dangers of dog fighting and how these changes are a must. Animals involved in these fights are often severely injured or killed during the fight. These fights may last for hours until one of the animals quits or dies. These animals do not receive veterinary attention. Losers that do not die may be tortured, starved to death or killed

outright by their owners. Other animals, such as owned pets or strays may be stolen and used as "bait" to train fighting dogs, often suffering greatly before they die. Dog fighting promotes crime such as violence to others, theft, drug use/possession/distribution, illegal weapons use/possession and gambling. It creates fear and intimidation in neighborhoods. The ADFC does not and will not be intimidated or back down and will do all they can to make sure animals are safe from hard. If you suspect dog fighting reach out using the information below. #### Do Dogs Grieve The Loss of their Owners?

There are plenty of literature to help humans grieve the loss of a pet, but what about the pet? Do pets grieve the loss of their humans? Pets actually do show signs of loss and mourning in ways that the family may not recognize. Although somewhat different, they do feel the loss of loved ones. Many have a significant degree of attachment to their owner that leads to anxiety and distress when even short-term separation is thrust upon them, let alone bereavement. Dogs that have the hyper-attachment syndrome of separation anxiety are likely to be hard hit following their owners' demise. While we can't ask a dog how he feels, we can (and do) sometimes see all the visible signs of depression in bereft dogs that we see in a recently bereaved or otherwise depressed person. Following acute loss of a closely bonded owner, dogs can suffer the pangs of separation anxiety or depression just as people do. The extent of the suffering is directly proportional to the strength of the bond with the owner and is a function of the dog's reliance and perceived dependence on that person. Owners who feed into a dog's intense dependence on them are more likely to have dogs that do not cope well when left alone for any reason. The emotional pain dogs feel on their owners death is an extension of, and extreme, protracted version of separation anxiety. While we all enjoy a close bond with our pets, and children for that matter, it is as well to prepare them to stand on their own four/two feet (respectively) so that they are not adrift should anything happen to us.
